HKCAAVQ wins APQN Quality Award

The HKCAAVQ has won an Asia-Pacific Quality Network (APQN) Quality Award in the category of training and support of reviewers to recognise the HKCAAVQ's contributions to training and support of reviewers locally and regionally and its development of sound and effective materials for training. The Award was presented to Prof William Lee, Executive Director of the HKCAAVQ, at the APQN Conference held in Vietnam on 7 March 2014.



HKCAAVQ appoints Specialists

The HKCAAVQ Specialists Appointment Ceremony was held on 17 January 2014. Over 50 academics, professionals and experts from various industries and areas of study and training attended the Ceremony to recognise their appointment to serve on accreditation panels.

The Conference, organised by the Knowledge and Human Development Authority (KHDA) of Dubai, aimed to foster an active conversation to address current issues in international quality assurance and improve the quality assurance process for international branch campuses.

News Roundup

Government refines measures in relation to Hong Kong's development as regional education hub

The Hong Kong Special Administrative Region (HKSAR) Government has introduced the following technical refinements to the existing policy in support of Hong Kong's development as a regional education hub:

1. Extending student exchange to sub-degree programmes;
2. Extending the internship arrangement for non-local students at undergraduate or above level to those enrolled in full-time locally-accredited sub-degree local programmes with a study period of not less than two academic years;
3. Aligning the length of stay granted to non-local students admitted to study full-time locally-accredited post-secondary programmes upon entry with the normal duration of study programmes;
4. Aligning the policy on admission of non-local students of full-time locally-accredited non-local programmes at undergraduate or above level with that governing other full-time locally-accredited self-financing local programmes at the same level.

Education Bureau signed cooperation arrangement with NZQA

The Education Bureau (EDB) of the HKSAR Government signed the Cooperation Agreement with the New Zealand Qualifications Authority (NZQA) on the Development of Qualifications Frameworks on 28 March 2014. This arrangement builds on the Arrangement on Education Cooperation between the EDB and the Ministry of Education, New Zealand, which was signed in 2011.

Just Published

For the purpose of increased transparency in the quality assurance process, the HKCAAVQ decided to publish summary accreditation reports online. For Initial Evaluation (IE) and Programme Validation (PV) / Programme Revalidation (Re-PV) of local programmes with contracts signed on or after 1 March 2013, summary accreditation reports will be published for public access on the HKCAAVQ website. As of the end of April 2014, a total of 25 summary accreditation reports were published. Among them, there are 17 IE reports, 4 PV reports, 3 combined IE and PV reports and 1 Re-PV report.

Latest Update

Guidelines for Promoting Accredited Programmes and Programmes undergoing Accreditation

The HKCAAVQ issued the revised Guidelines for Promoting Accredited Programmes and Programmes undergoing Accreditation on 1 April 2014. All operators and qualifications granting bodies that would like to promote their programmes accredited by, or undergoing accreditation of the HKCAAVQ shall adopt and comply with these guidelines. Current Projects

Quality Management System

The HKCAAVQ has initiated an IT Infrastructure Development Project to create a "Quality Management System", incorporating an integrated database and central repository to streamline our work processes and facilitate communication and exchange of information among our staff and stakeholders. With the support of the Education Bureau of the HKSAR Government through the Quality Enhancement Support Scheme, phase one of the IT Infrastructure Project has commenced and we are now planning for phase two to further strengthen our accreditation and assessment services.

Training Workshop on Use of Credit under Qualifications Framework (QF)

The HKCAAVQ has been commissioned by the Education Bureau to run six workshops on the use of QF credits in 2014 for QR operators and organisations that intend to participate in the QF. The HKCAAVQ is appointed as the Qualifications Register (QR) Authority under the Accreditation of Academic and Vocational Qualifications Ordinance (Cap 592) and is responsible for administering the QR.
