This accreditation report is issued by the Hong Kong Council for Accreditation of Academic and Vocational Qualifications (HKCAAVQ) in its capacity as the Accreditation Authority as provided for under the Accreditation of Academic and Vocational Qualifications Ordinance (Cap 592) (AAVQO). This report outlines the HKCAAVQ's determination, the validity period of the determination as well as any conditions or restrictions on the determination.

#### 1. Introduction

- 1.1 Caritas Institute of Community Education (CICE), a self-financing institution, has been committed to promoting lifelong learning and operating a wide variety of courses ranging from short courses to award-bearing programmes. These courses / programmes are very much vocationally oriented but also provide for life enrichment and serve people from all walks of life. In addition, CICE is one of the major partners with various government bureaux and statutory bodies in providing government sub-vented programmes to help the working population better equip themselves with skills for employment.
- 1.2 Based on the Service Agreement, the HKCAAVQ was commissioned by the Caritas Institute of Community Education (明愛社區書院) (the Operator) to assess and determine whether the following learning programmes achieve the stated objectives and meet the Qualifications Framework (QF) standards at the proposed QF Levels:
  - (1) Certificate in Beauty Care (QF Level 2);
  - (2) Certificate in Facial Electrical Treatment (QF Level 3);
  - (3) Certificate in Trendy Make-up and Design (QF Level 3);
  - (4) Certificate in Nail Art, Manicure and Pedicure Care (QF Level 3);
  - (5) Diploma in Facial Electrical Treatment and Trendy Make-up Design (QF Level 3);
  - (6) Diploma in Health Care Studies; and
  - (7) Diploma in Social Service Management.
- 1.3 The accreditation exercise was conducted according to the relevant accreditation guidelines referred to in the Service Agreement and the Terms of Reference stated therein. An on-site visit took place on 10-11 April 2014.

#### 3. Programme Details

The following is the programme information provided by the Operator.

### 3.1 Programme Objectives

#### Certificate in Beauty Care (QF Level 2)

- Describe the basic body structure, organization, mechanism and functions of human physiological systems;
- Explain the ingredients of various skin care products and the appropriate proper procedures of beauty treatment for different skin types;
- Demonstrate the techniques of performing necessary patch test before tinting eyelashes and eyebrows;
- Explain the basic mechanism, functions, operating methods and procedures as well as safety rules of common facial electrical equipment, e.g., facial steamer;
- Differentiate the types and techniques of non-permanent hair removal; and
- Explain the essential labour and commercial law relevant to the beauty industry.

#### Certificate in Facial Electrical Treatment (QF Level 3)

• Explain the usage, functions and safety precautions of the seven commonly used facial electrical equipment such as High Frequency, Galvanism and Faradic, etc.;

- Identify the general symptoms and describe the transmission process of common infectious diseases; and
- Demonstrate the proper use of the facial electrical equipment properly and clearly explain the procedures and precautions taken.

### Certificate in Trendy Make-up and Design (QF Level 3)

- Explain and apply the chromatology in make-up design;
- Analyze the essence of different types of make-up design and impact of different environmental factors so as to apply professional make-up skills to perform evening make-up, bridal and banquet make-up;
- Apply fashionable, photographic and stage make-up skills for different scenes and themes; and
- Illustrate the characteristics and use of different special effect make-up products and tools.

# Certificate in Nail Art, Manicure and Pedicure Care (QF Level 3)

- Apply the knowledge of manicure, pedicure, hand and foot care to provide the manicure and pedicure treatments; and
- Demonstrate the skills of applying the acrylic, UV gel nail and fibre nail tips.

### Diploma in Facial Electrical Treatment and Trendy Make-up Design (QF Level 3)

- Apply the knowledge and skills of beauty care in make-up design;
- Explain the method, functions of the seven common facial electrical equipment and operate them properly in providing beauty care treatments to clients; and
- Apply professional make-up skills to produce appropriate make-up designs for clients with appropriate consideration of different environmental factors.

# Diploma in Health Care Studies

- Provide students with a solid foundation in the principle and practice of personal caring skills in various health care settings;
- Train students to demonstrate proficiency in providing holistic service to clients in welfare settings, particularly to the elderly and persons with disabilities;
- Familiarize students with the requirements for service quality standard in maintenance as well as restoration of health and prevention of illness for both clients and their relatives;
- Develop students' ability to perform as efficient and effective health care team members;
   and
- Enhance students' generic academic competence, self-awareness, and career planning skills for work and further study at post-secondary level.

#### Diploma in Social Service Management

- Provide a structured programme emphasizing social service skills;
- Equip students with the general knowledge about social service;
- Develop and nurture students' critical thinking skills on social issues and concerns;
- Raise students' awareness of social issues; and
- Enhance students' generic academic competence, self-awareness, and career planning skills for work and further study at post-secondary level.

#### 3.2 Programme Intended Learning Outcomes

#### Certificate in Beauty Care (QF Level 2)

Upon completion of the programme, students should be able to:

- Explain the basic human body structure, mechanism and functions; accurately analyze a client's skin condition and needs to choose appropriate product ingredients and provide appropriate facial beauty care treatment according to personal hygiene standard and operation guidelines;
- Apply techniques of patch test and tinting to clients in accordance with the personal hygiene standard and operation guidelines; produce clear record of the test results and other relevant information and provide clients with the method and advice on aftertreatment home care;
- Explain the basic mechanism, functions, operating procedures of the facial electrical equipment, choose and operate suitable equipment to provide beauty care to clients in accordance with the operating and safety guidelines, personal hygiene standard and proper operating procedures under the guidance;
- Apply the basic theory of human hair as well as a variety of non-permanent hair removal techniques and products to provide non-permanent hair removal treatment to clients according to personal hygiene standard and operational guidelines; and
- Identify and comply with relevant laws and regulations during daily operations in the beauty salon to establish a good corporate image and enhance client confidence.

# Certificate in Facial Electrical Treatment (QF Level 3)

Upon completion of the programme, students should be able to:

- Explain the basic mechanism, functions, operating procedures, techniques, routine cleaning and maintenance methods and operating guidelines, electrical safety, personal hygiene and operational guidelines of the facial electrical equipment; and properly operate seven commonly used facial electrical equipment for beauty treatments (e.g., High Frequency, Galvanism and Faradic, etc.);
- Identify and differentiate the symptoms and transmission of various infectious diseases
  and take appropriate preventive measures in beauty routine work procedures; and
  tactfully decline the request for beauty service or products trial from those who have
  identifiable symptoms of infectious diseases and tactfully advise the clients to seek
  appropriate treatment; and
- Analyze clients' body and skin condition and needs so as to adopt appropriate electrical equipment to provide suitable beauty treatments.

#### Certificate in Trendy Make-up and Design (QF Level 3)

Upon completion of the programme, students should be able to:

- Apply appropriate colour matching to make-up in cosmetic-related work;
- Demonstrate correct use of colour matching skills in evening, bridal and special occasion make-up based on sound judgement on the cosmetic purposes, indoor or outdoor environmental factors;
- Design and produce photographic, fashionable and stage make-up styles according to specific themes, objectives and scenes by applying appropriate cosmetic products, and make-up skills; and
- Choose and apply appropriate special effect make-up products, tools and skills to produce different special effect make-up styles to create the intended image of a character.

#### Certificate in Nail Art, Manicure and Pedicure Care (QF Level 3)

Upon completion of the programme, students should be able to:

• Perform manicure and pedicure treatments in beauty salon in accordance with personal hygiene code of practice, provide basic nail care service, such as soaking, nail trimming, 'dead' cuticle removing, applying base coat and top coat, etc;

- Analyze the client's needs and the condition of the nails and perform the skilled tasks of nail care and enhancement safely and effectively, such as nail treatments; and
- Apply the techniques of nail extension and maintenance to provide acrylic nail, UV gel nail and fibre nail tips treatments.

# Diploma in Facial Electrical Treatment and Trendy Make-up Design (QF Level 3)

Upon completion of the programme, students should be able to:

- Apply techniques of beauty care and accurately analyze client's skin types and needs to choose appropriate product to provide beauty care treatment according to personal hygiene standard and operation guidelines;
- Explain the functions, mechanism, operating procedures, techniques, routine cleaning and maintenance methods and operating guidelines, electrical safety, personal hygiene and operational guidelines of the seven commonly used facial electrical equipment; and according to clients' body and skin condition and needs, adopt appropriate electrical equipment to provide suitable beauty treatments properly; and
- Design and produce make-up styles according to specific themes, objectives and scenes by applying appropriate cosmetic products and make-up skills.

# Diploma in Health Care Studies

Upon completion of the programme, students should be able to:

- Apply mathematical skills and statistical concepts in business and social welfare setting;
- Describe the roles and ethical responsibilities of health care provider in welfare settings;
- Apply learned knowledge and skills in caring for the elderly and persons with disabilities;
- Perform the procedures for accident prevention and first-aid;
- Apply health care service management knowledge in residential care setting; and
- Apply the generic skills (English, Chinese and interpersonal) in coping with future challenges in work and study at post-secondary level.

#### Diploma in Social Service Management

Upon completion of the programme, students should be able to:

- Apply mathematical skills and statistical concepts in business and social service setting;
- Analyze social issues at personal, group and societal levels with sociological perspectives and reflect the roles of individuals in relation to Hong Kong and the world;
- Plan and implement activities and programmes for diverse social groups in social service setting by applying theories in psychology, counselling, IT and management;
- Evaluate the impact of social policies on the social groups in Hong Kong; and
- Apply the generic skills (English, Chinese and interpersonal) for workplace and further study at post-secondary level.
