This accreditation report is issued by the Hong Kong Council for Accreditation of Academic and Vocational Qualifications (HKCAAVQ) in its capacity as the Accreditation Authority as provided for under the Accreditation of Academic and Vocational Qualifications Ordinance (Cap 592) (AAVQO). This report outlines the HKCAAVQ's determination, the validity period of the determination as well as any conditions or restrictions on the determination.

#### 1. Introduction

- 1.1 The Yi Jin Diploma (YJD) programme was accredited by the HKCAAVQ in August 2013 with a validity period of three years starting from the 2013/14 academic year to be operated by seven member institutions of the Federation for Self-financing Tertiary Education (FSTE) including the School of Business and Information Systems, Vocational Training Council (SBI, VTC/the Operator). At the time of the accreditation exercise for the YJD programme, the HKCAAVQ was informed that the FSTE member institutions may propose new and/or revamped Elective Clusters before commencement of each academic year.
- 1.2 For implementation in the 2014/15 academic year, the SBI, VTC proposed an Elective Cluster, Motorcycle Servicing and Automotive Technology [電單車及汽車科技], which was developed with reference to the Specification of Competency Standards (SCS) developed by the Automotive Industry Training Advisory Committee of the Qualifications Framework (QF) and the Qualifications Guidelines for the SCS-based Courses under the QF.
- 1.3 Following the advice of the Education Bureau to the FSTE and its member institutions to award standalone qualifications to YJD students on successful completion of a SCS-based Elective Cluster/Course, this Elective Cluster of SBI, VTC is to be accredited by the HKCAAVQ leading to the SCS-based qualification leading, Certificate in Motorcycle Servicing and Automotive Technology (Elective Cluster of Yi Jin Diploma) [電單車及汽車科技 (毅進文憑選修群組) 證書] and to be uploaded separately on the Qualifications Register of the QF. On successful completion of the Elective Cluster, students of the YJD programme will be awarded the Certificate in Motorcycle Servicing and Automotive Technology (Elective Cluster of Yi Jin Diploma).
- 1.4 Based on the agreement, the HKCAAVQ was commissioned by the FSTE to assess and determine whether the following learning programme of the SBI, VTC achieves the stated objectives and meets the QF standard at QF Level 3:
  - (1) Certificate in Motorcycle Servicing and Automotive Technology (Elective Cluster of Yi Jin Diploma)
- 1.5 The accreditation exercise was conducted according to the relevant accreditation guidelines referred to in the agreement and the terms stated therein.

## 3. Programme Details

#### 3.1 Programme Objectives

The programme aims at focusing on the devising process plan in Automotive Technology. Students will be provided with the necessary knowledge related to vehicle technology, reasoning ability and practical skills which are appropriate to industry needs, and to use them to complete occupational tasks successfully. They will be equipped with all-round and balanced learning opportunities in the areas of social, cultural and professional competencies; building up problem-solving and decision making abilities in the industry context and lifelong personal development. Furthermore, they will be trained to strengthen their communication and presentation skills as required by the industry. Students are encouraged to be observant, critical, appreciative and responsive in the ever changing and challenging world of vehicle repair industry.

#### 3.2 Programme Intended Learning Outcomes

Upon completion of the programme, students should be able to:

- apply the knowledge and skills in the operation and working principles of the main systems of vehicles;
- carry out inspection, servicing and trouble shooting on brake and suspension systems;
- carry out inspection, servicing and trouble shooting on petrol engine management systems:
- carry out inspection, servicing and trouble shooting on petrol and diesel engines;
- carry out inspection, servicing and trouble shooting on transmission systems;
- carry out testing and inspection of motorcycle components; and
- carry out inspection, servicing and trouble shooting on diesel fuel and LPG fuel systems.
