1. TERMS OF REFERENCE

1.1 Based on the Service Agreement (No.: VA846), the Hong Kong Council for Accreditation of Academic and Vocational Qualifications (HKCAAVQ), in the capacity of the Accreditation Authority as provided for under the Accreditation of Academic and Vocational Qualifications Ordinance (Cap 592) (hereafter Ordinance), was commissioned by Beacon (Evening) College (Mong Kok) (Operator) to conduct a Learning Programme Re-accreditation Exercise with the following Terms of Reference:

- (a) To conduct an accreditation test as provided for in the Ordinance to determine whether the programme of the Beacon (Evening) College (Mong Kok) (the Operator) meet the stated objectives and QF standard and can continue to be offered as an accredited programme
 - (i) Certificate of IELTS Exam Preparation
- (b) To issue to the Operator accreditation report(s) setting out the results of the determination in relation to (a) and (b) by HKCAAVQ.

1.2 The accreditation exercise was conducted according to the relevant accreditation guidelines referred to in the Service Agreement. A site visit took place on 14 May 2018.

2. HKCAAVQ'S DETERMINATION

Learning Programme Re-accreditation

2.1 HKCAAVQ has determined that the Certificate of IELTS Exam Preparation meets the stated objectives and QF standard at Level 2, and can be offered as an accredited programme with a validity period from 1 October 2018 to 30 September 2020.

3. INTRODUCTION

3.1 Beacon (Evening) College (Mong Kok) is one of the branches under the governance of the Board of Directors of Beacon College. It offers a wide variety of education programmes targeted at different age groups ranging from children to working adults.

4. PROGRAMME DETAILS

The following is the programme information provided by the Operator.

4.1 Programme Objectives

The programme aims to enhance learners' English language proficiency for study and work through training in IELTS-test-taking skills covering the four skills of English language to reach the English language competence comparable to the exit banding 4.5 of the IELTS exam.

4.2 Programme Intended Learning Outcomes

Upon completion of the programme, students should be able to:

- PILO-1. write effectively and accurately on a range of given topics related to the workplace, daily life and other common topics in IELTS Exam;
- PILO-2. describe, summarize and make comparisons using data from graphs and figures;
- PILO-3. identify main ideas from dialogues and speeches of given texts;
- PILO-4. give effective self-introduction, presentations and interact effectively on a range of given topics related to the workplace, daily life and other common topics in IELTS Exam; and
- PILO-5. read for main ideas, identify facts/opinions and understand the structure of an argument in given reading texts.

4.4 Graduation Requirements

- i. Attain the minimum attendance requirement of 70%; &
- ii. Obtain at least 50% marks for each part (i.e. Listening, Reading, Writing and Speaking) of the Final Assessments; &
- iii. Obtain at least 50% marks of the whole programme

4.5 Admission Requirements

- attained at least Grade E in English Language in the HKCEE (Syllabus A); OR
- completion of Secondary 5 with pass grade in English on the school report at either Secondary 4 or 5; OR
- attained an overall score of 3.5 in IELTS (either Academic Module or General Training Module); OR
- completed the Entrance Assessment Test with pass grade (i.e. 50%)

5. IMPORTANT INFORMATION REGARDING THIS ACCREDITATION REPORT

5.1 Variation and withdrawal of this Accreditation Report

- 5.1.1 This Accreditation Report is issued pursuant to section 5 of the AAVQO, and contains HKCAAVQ's substantive determination regarding the accreditation, including the validity period as well as any conditions and restrictions subject to which the determination is to have effect.
- 5.1.2 HKCAAVQ may subsequently decide to vary or withdraw this Accreditation Report if it is satisfied that any of the grounds set out in section 5 (2) of the AAVQO apply. This includes where HKCAAVQ is satisfied that the Operator is no longer competent to achieve the relevant objectives and/or the Programme no longer meets the standard to achieve the relevant objectives as claimed by the Operator (whether by reference to the Operator's failure to fulfil any conditions and/or comply with any restrictions stipulated in this Accreditation Report or otherwise) or where at any time during the validity period there has/have been substantial change(s) introduced by the Operator after HKCAAVQ has issued the accreditation report(s) to the Operator and which has/have not been approved by HKCAAVQ. - 5.1.3 If HKCAAVQ decides to vary or withdraw this Accreditation Report, it will give the Operator notice of such variation or withdrawal pursuant to section 5(4) of the AAVQO.
- 5.1.4 The accreditation status of the Operator and/or Programme will lapse immediately upon the expiry of the validity period or upon the issuance of a notice of withdrawal of this Accreditation Report.

5.2 Appeals

- 5.2.1 If the Operator is aggrieved by the determination made in this Accreditation Report, then pursuant to Part 3 of the AAVQO the Operator has a right of appeal to the Appeal Board. Any appeal must be lodged within 30 days of the receipt of this Accreditation Report.
- 5.2.2 If the Operator is aggrieved by a decision to vary or withdraw this Accreditation Report, then pursuant to Part 3 of the AAVQO the Operator has a right of appeal to the Appeal Board. Any appeal must be lodged within 30 days of the receipt of the Notice of Withdrawal.
- 5.2.3 The Operator should be aware that a notice of variation or withdrawal of this Accreditation Report is not itself an accreditation report and the right to appeal

against HKCAAVQ's substantive determination regarding accreditation arises only from this Accreditation Report.

- 5.3.2 Only learners who commence the study of the named accredited learning programme during the validity period and who have graduated with the named qualification listed in the QR will be considered to have acquired a qualification recognised under the QF.
