# HIGHER DIPLOMA IN EARLY CHILDHOOD EDUCATION

**JANUARY 2019** 

This accreditation report is issued by the Hong Kong Council for Accreditation of Academic and Vocational Qualifications (HKCAAVQ) in its capacity as the Accreditation Authority as provided for under the Accreditation of Academic and Vocational Qualifications Ordinance (Cap. 592) (AAVQO). This report outlines the HKCAAVQ's determination, the validity period of the determination as well as any conditions or restrictions on the determination.

#### 1. Introduction

- 1.1 Tung Wah College (TWC) was incorporated in 2010 as a wholly-owned subsidiary of the Tung Wah Group of Hospitals; and operates independently as a self-financing institution. TWC went through an Institutional Review (IR) by HKCAAVQ in October 2010; and was approved by the Chief Executive in Council in 2011 to register under the Post-Secondary Colleges Ordinance (Cap 320) as a degree-awarding institution.
- 1.2 The Hong Kong Council for Accreditation of Academic and Vocational Qualifications (HKCAAVQ), in the capacity of the Accreditation Authority as provided for under the Accreditation of Academic and Vocational Qualifications Ordinance (Cap. 592), was commissioned by Tung Wah College to conduct learning programme re-accreditation with the following Terms of Reference:
  - a) To conduct an accreditation test as provided for in the AAVQO to determine whether the Higher Diploma in Early Childhood Education programme (HDECE) of Tung Wah College (the Operator) meets the stated objectives and QF standard and can continue to be offered as an accredited programme from the 2019/20 academic year; and
  - b) To issue to the Operator an accreditation report setting out the results of the determination in relation to (a) by HKCAAVQ.
- 1.3 The accreditation exercise was conducted according to the relevant accreditation guidelines referred to in the Service Agreement and the Terms of Reference stated therein. A site visit took place on 15-16 November 2018.

#### 2.1.1 Restriction

The College is to ensure that the Programme is approved by the Education Bureau and the Social Welfare Department so that graduates will be eligible for registration as Qualified Kindergarten Teachers and Child Care Workers and Child Care Supervisors respectively.

The College is to submit relevant documents to HKCAAVQ on the fulfilment of the restriction before enrolling the 2019/20 intake.

#### 2.1.2 Recommendations

- (a) The College should review and revise the syllabus of *CHI 2003*Putonghua to reflect the actual teaching and learning of the course.
- (b) The College should review, and revise where necessary, the relevant parts of the QA guidelines to ensure that all staff concerned are fully aware of the due processes for programme changes.
- (c) The College should reconsider the time-frame of the Annual Programme Review for timely follow-up.

#### 3.1 Programme Objectives

- To integrate understanding of special educational needs of children with developmental challenges in early childhood education;
- To utilise critical, analytical and problem solving skills;
- To apply effective interpersonal skills in communication with child care professionals, children and parents in early childhood settings;
- To demonstrate the educational and professional responsibilities in early childhood settings; and
- To recognise the capacity for continuous independent learning and reflective practice.

- Have completed the minimum required credit units as prescribed for the Programme with a graduation Grade Point Average ("gGPA") of at least 2.0
- Have achieved GPA of 1.0 or above in all courses in the Programme;
- Have completed the 30 hours of Community Service Programme.

#### 3.5 Admission Requirements

- Have obtained Level 2 in five HKDSE subjects including Chinese Language and English Language ("22+222"). (Each applicant is allowed to use not more than two Applied Learning subjects in the application); OR
- Have obtained a pass in one AL subject or passes in two AS subjects in HKALE and five passes in HKCEE including Chinese Language and English Language; OR
- Have obtained a pass in one AL subject or passes in two AS subjects in HKALE and three passes in HKCEE plus Level 2 for Chinese Language and English Language; OR
- Have successfully completed a Pre-Associate Degree programme (with GPA 2.5 or above); OR
- Have successfully completed Yi Jin Diploma programme; OR
- Have obtained equivalent qualifications; OR
- Have reached the age of 21 years old and above.
