This accreditation report is issued by the Hong Kong Council for Accreditation of Academic and Vocational Qualifications (HKCAAVQ) in its capacity as the Accreditation Authority as provided for under the Accreditation of Academic and Vocational Qualifications Ordinance (Cap 592) (AAVQO). This report outlines HKCAAVQ's determination, the validity period of the determination as well as any conditions or restrictions on the determination.

# 1. Introduction

- 1.1 The Hong Kong Academy for Performing Arts (the Academy) offers five accredited postgraduate degree programmes leading to the awards of Master of Music (MMus) and Master of Fine Arts (MFA) in four areas: Dance, Drama, Cinema Production, and Theatre and Entertainment Arts. Both the MMus Programme and MFA in Dance Programme were first accredited in 2006 and re-accredited in 2010.
- 1.2 Based on the Service Agreement, the HKCAAVQ was commissioned by the Academy to conduct a learning programme re-accreditation (re-LPA) exercise with the following Terms of Reference:
  - (a) To determine whether the Master of Music Programme and Master of Fine Arts in Dance Programme offered by the Academy meet the stated objectives and Qualifications Framework (QF) standard and can continue to be offered as accredited programmes from the 2015/16 academic year; and
  - (b) To issue to the Academy an accreditation report covering the named programmes setting out HKCAAVQ's determination in relation to (a) above.
- 1.3 A site visit took place on 18-19 June 2015.

# 2. HKCAAVQ's Accreditation Determination

# 2.1.1 Recommendations

(a) The School of Music should revisit the syllabus of *Zheng Ensemble* and consider how it may enrich the curricular content and enhance the existing approach in order to more effectively nurture the talent of the student.

- (b) The Academy should strengthen students' English language proficiency and communication skills before class starts in September.
- (c) The Academy should continue their review of the academic and administrative structure for the College of Allied Arts to maximize efficiency and effectiveness.
- (d) The Academy should further promote practice-based research as a means for staff development.

# 3.1 Programme Objectives

- Extend students' knowledge and experience of the major repertoire within their chosen specialism so they gain comprehensive fluency over a range of styles;
- Encourage students to develop distinct artistic personalities and voices, and to develop an area of performance or composition specialism through focused activity in that area;
- Cultivate in students a broad range of academic and verbal competencies in the organisation, interpretation, and evaluation of knowledge through supporting historical, theoretical, and interdisciplinary studies;

- Encourage students to develop capabilities for critical reflection, and apply them in relation to their own work as well as to the work of others;
- Help students develop into articulate advocates of the performing arts and potential leaders in the profession; and
- Stimulate students' awareness of the role of the musician in society and encourage their active contribution and participation in the artistic life of the community.

# Master of Fine Arts in Dance Programme

- Provide an environment in which in-depth and comprehensive learning about the creation, performance, and dissemination of dance can develop;
- Provide integrated theoretical and practical contexts in which students can conceptualise, analyse, synthesise, and articulate the complex relationship of dance to culture at large, and to their own career paths;

- Provide an environment that fosters innovative and quality-based research in dance practice;
- Provide a platform for original contributions in fields such as choreography, education, documentation, dissemination, and performance; and

# 3.4 Graduation Requirements

# For Both Programmes

To be eligible for the award of MMus or MFA in Dance degree, students are required to (a) accumulate the total number of credits required for the Programme as stipulated in the curriculum, which includes the number of credits for the required courses and the stipulated number of credits for electives; (b) attain for the whole Programme a *Major Study* GPA of 3.0 or above; and (c) obtain a cumulative GPA of 2.7 or above.

# 3.5 Admission Requirements

# Master of Music Programme

For admission to the Programme, an applicant should hold a Bachelor Degree in Music, normally with honours not lower than second class upper division or an average grade not lower than "B" in undergraduate courses from a recognised university or an approved equivalent qualification. Graduates of the BMus (Hons) Degree from the Academy should have achieved a Final Year Grade Point Average

(GPA) of 3.3 or above in the Major Study and an Overall Programme GPA of 2.7 or above.

# Master of Fine Arts in Dance Programme

For admission to the Programme, an applicant should hold a BFA (Hons) Degree in Dance from the Academy or an undergraduate degree in a relevant discipline from a recognised institution or qualification of equivalent standard from the Academy or from another recognised institution, and a Final Year GPA of 3.0 (grade B) or above in the undergraduate degree Major Study or equivalent.

# For Both Programmes

An applicant is also expected to satisfy the Academy's language requirements. For a Bachelor Degree attained from an institution where the medium of instruction is not English, a score from Test of English as a Foreign Language (TOEFL) or International English Language Testing System (IELTS) is required (**Appendices 1 & 2**), and for those who cannot demonstrate achievement in these tests, the Academy's English Placement Test is considered an acceptable alternative. An applicant applying for a Major Study in Chinese Music whose entrance qualification has not been obtained from an institution where the medium of instruction is Chinese will be required to pass the Academy's Chinese Language Proficiency Test.

An applicant who does not satisfy the normal entry requirements may be considered exceptionally on a case-by-case basis, subject to the approval of the Board of Graduate Education.

# 4. Substantial Change

4.1 Maintenance of the HKCAAVQ accreditation status during the validity period is subject to no substantial change being made without prior approval from HKCAAVQ.

The Operator should apply separately to have their quality-assured qualifications entered into the QR.
- 5.2 Only learners who are admitted to the named accredited learning programme during the validity period and who have graduated with the named qualification uploaded in the QR will be considered to have acquired a qualification recognised under the QF.

Candidates applying for a Major Study in Chinese Music whose entrance qualification has not been obtained from an institution where the medium of instruction is Chinese

	will be required to pass the Academy's Chinese Language Proficiency Test.

Applicants who cannot demonstrate that they can obtain the IELTS or TOEFL scores listed above in (b) may be deemed to have satisfied the language requirement by virtue of a pass in the Academy English Placement Tests. Shortlisted applicants must complete the Academy English computer, written, and spoken admission tests during their interview. Based on the scores, applicants may be required to pass the Intensive English Enhancement Course as a condition of their acceptance.
